**Nomination requirements:** Nominations must begin in the foaling year and all conditions and requirements for the sire, dam, weanling, yearling and two-year-old years must have been fulfilled. All payments must be made to maintain eligibility. Futurity ends after two-year-old year.

## ASR NATIONAL THREE-YEAR-OLD FUTURITY

**Nomination requirements:** Nominations must begin in the foaling year and all conditions and requirements for the sire, dam, weanling, yearling, two-year-old and three-years-old years must have been fulfilled. All payments must be made to maintain eligibility.

## ASR TWO-YEAR-OLD SWEEPSTAKES

**Nomination requirements:** No sire, dam, or weanling nominations required. Nominations must begin with the yearling year and all conditions and requirements for the yearling and two-year-old years must have been fulfilled.

## ASR THREE-YEAR-OLD SWEEPSTAKES

**Nomination requirements:** No sire, dam, or weanling nominations required. Nominations must begin with the yearling year and all conditions and requirements for the yearling, two-year-old and three-year-old years must have been fulfilled.

## ASR FOUR-YEAR-OLD SWEEPSTAKES

**Nomination requirements:** No sire, dam, weanling, yearling or two-year-old nominations required. Nominations must begin with the three-year-old year and all conditions and requirements for the three-year-old and four-year-old years must have been fulfilled.

## ASR FUTURITY OF KENTUCKY

**Who's eligible to show:** Weanlings, Yearlings, Two-Year-Olds

**How are they shown:** Weanlings & Yearlings In-Hand, Two-Year-Olds In Harness. Foals are not required to be shown to maintain eligibility.

**Where are they shown:** Kentucky State Fair, Louisville, KY.

**Prize money awarded in 2014:** \$50,168

## ASR AMATEUR FUTURITY OF KENTUCKY

**Who's eligible to show:** Weanlings, Yearlings, Two-Year-Olds

**How are they shown:** Weanlings, Yearlings and Two-Year-Olds In-Hand. Foals are not required to be shown to maintain eligibility. Entries shown exclusively by amateurs, although a horse may be owned by a professional.

**Where are they shown:** Kentucky State Fair, Louisville, KY.

**Prize money awarded in 2014:** \$17,036

## ASR NATIONAL THREE-YEAR-OLD FUTURITY

**Who's eligible to show:** Three-Year-Olds

**How are they shown:** Only as three-year-olds in one of five classes: three-gaited, five-gaited, fine harness, three-gaited park pleasure (professional may ride), and three-gaited park.

**Where are they shown:** Kentucky State Fair, Louisville, KY.

**Prize money awarded in 2014:** \$71,567

## ASR TWO-, THREE- AND FOUR-YEAR-OLD SWEEPSTAKES

**How are they shown:** Show as two-year-olds in fine harness and three-gaited park. Show as three and four-year-olds in three-gaited, five-gaited, fine harness, and three-gaited park pleasure (professional may ride).

**Where are they shown:** Two- and Three-Year-Olds at All American Horse Classic, Indianapolis, IN. Four-Year-Olds at Kentucky State Fair, Louisville, KY. Judge selection by vote of Sweepstakes participants. Prize money is divided between the recorded owner at the time of competition and the nominator(s). Prize money awarded in 2014: \$144,359

## SPORT HORSE INCENTIVE PROGRAM

**Who's eligible to show:** Eligible horses are purebred Saddlebreds registered with the American Saddlebred Registry (ASR), and Half-Saddlebreds registered with the Half-Saddlebred Registry of America (HSRA). Owner must be a current competing member in good standing with ASHA and the horse must be enrolled in the program in the competition year (December 1 – November 30).

**Where are they shown:** Eligible competitions/events are limited to those recognized by National Equine Organizations, which include USEF, FEI, EC, USDF, WDAA, USHJA, ADS, AERC, NRHA, USEA, NATRC and ACTHA.

**How are they shown:** Eligible all-breed disciplines are Dressage, Western Dressage, Hunters, Jumpers, Combined Driving, Pleasure Driving, Reining, Eventing, Endurance, Limited Distance and Competitive Trail.

**How it works:** If enrolled by April 1 each year, points earned for the entire competition year will be considered toward final scores in the program. If enrolled after April 1 of the competition year, points will count only for the period beginning five days before the enrollment form is sent to the ASR office.

**Payments required:** The annual enrollment fee is \$100 per horse.
